Report on Remuneration: resolution pursuant to art. 123-ter, paragraph 6 of Legislative Decree 58/1998

Distinguished Shareholders,

Pursuant to the provisions of art. 123-ter of Legislative Decree no. 58/1998, from the current year, the Shareholders' Meeting is asked to express its vote with regard to remuneration policies for the Management Board Members, General Managers and Key Managers, as well on the procedures used to adopt and implement said policies.
