## **WHEREAS**

- The Ordinary Shareholders' Meeting of INTESA SANPAOLO S.P.A. ("the Bank") has been summoned to be held on 22 April 2013 on single call. Item 2 on the agenda of the Meeting is the appointment of Supervisory Board members for the financial years 2013-2014-2015.
- The Parties' stakes in the Bank's capital are the following:
  - Compagnia di San Paolo holds 1,506,372,075 ordinary shares, representing 9.718% of the ordinary share capital;
  - Fondazione Cariplo holds 767,029,267 ordinary shares, representing 4.948% of the ordinary share capital.
- The Parties intend to submit a joint list for the election of the Supervisory Board of the Bank.

## **AGREEMENTS**

- The Parties agree to determine in 19 the number of Supervisory Board members;
