INTESA SANPAOLO: CHANGE IN SHARE CAPITAL

Turin - Milan, 27 May 2019 – Intesa Sanpaolo hereby communicates the new composition of its subscribed and paid-in share capital following the finalisation of the merger by incorporation of Banca Apulia S.p.A. into Intesa Sanpaolo S.p.A..

The merger deed was signed on 14 May 2019 and registered in the competent Company Registers, with legal effects as of 27 May 2019. As a consequence, a total of 247,398 Intesa Sanpaolo ordinary shares, having no nominal value and regular dividend entitlement as coupon 43, were issued. This raised the share capital from 9,085,534,363.36 euro to 9,085,663,010.32 euro, divided into 17,509,728,425 ordinary shares without nominal value, as shown in the table below.
